- When the policy owner, or designee, revises or drafts a policy document, the revisions are reviewed by the Director of Policy and Legal Affairs.
- If the revisions are determined to include a substantive change to a policy or a new policy, the policy draft proceeds through the review and approval process before posting on the Policy Portal.
- If the revisions are determined to include no substantive change to existing policy (e.g., position title, office name, phone number, URL), the new version is posted on the Policy Portal.
